## **END-USER LICENSE AGREEMENT FOR SjurSound Audio Plugin Products**

IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH PRODUCT INSTALLATION: SjurSound Company's End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and the SjurSound Company, for the SjurSound Company software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you (referred to as "licensee") and the SjurSound Company, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. ## **1. GRANT OF LICENSE.** The SOFTWARE PRODUCT is licensed as follows:
